## 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor.

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

### Skin Contact:

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water and soap. If swelling, redness, blistering or irritation occurs seek medical assistance.

### Eye Contact:

Immediately wash in and around the eye area with large amounts of water for at least 15 minutes. Eyelids to be held apart. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport promptly to hospital or medical centre.

## Ingestion:

## 5. FIRE FIGHTING MEASURES

### Suitable Extinguishing Media:

Not combustible, however, if material is involved in a fire use: Alcohol resistant foam is the preferred firefighting medium but, if it is not available, normal protein foam can be used.

### Specific hazards arising from the chemical:

Non-combustible material. Decomposes on heating emitting toxic fumes including those of oxides of carbon.

### Special protective equipment and precautions for fire-fighters:

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition. Keep containers cool with water spray. Keep people away from and upwind of fire.

## 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. Do not allow container or product to get into drains, sewers, streams or ponds. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

Do NOT store near (or allow to contact) fertilizers, fungicides or pesticides. Store in the closed, original container, in a cool, well-ventilated area out of direct sunlight. Store in a locked room or place away from children, animals, food, feedstuffs, seed and fertilizers. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.
