#### DIRECTIONS FOR USE

**Restraints:** DO NOT USE in sheep less than 10 kg of bodyweight. DO NOT USE in ewes which are producing or may in the future produce milk that may be used or processed for human consumption.

**Contraindications:** This product is contraindicated for use in lambs under 6 weeks of age or less than 10 kg body weight.

Dosage and Administration: Use remaining product within 12 months of opening the container.

**ZOLVIX™** PLUS is a ready-to-use oral solution,

Check dose rates and drench gun before treatment commences. The dose for sheep and lambs is 0.5 mL/5 kg (1 mL/10 kg), equivalent to 2.5 mg monepantel/kg liveweight and 0.2 mg abamectin/kg liveweight. Drench sheep orally using an Elanco recommended drench gun. Maintain applicator gun carefully to ensure accurate dosage. After use, clean gun by flushing with warm, soapy water.

Sheep in excess of 80 kg body weight should be dosed at 1 mL/10 kg.

A representative sample of animals should be weighed before treatment. Dose the mob to the heaviest sheep by liveweight in each group (ewes, wethers, rams, lambs). DO NOT under dose. Where there is a large variation in size within the group, dose rates should be based on the label directions for each weight range.
